4. Nature bowl update. - Jaz made a flyer for Nature Bowl, started to put out online via emails, created event and shared it, sent out to all charter schools in Sutter, Butte and Yuba county and sent to all teachers and principals who participated in the past for Nature Bowl. Need to start actively sharing it.

5. Update on grants. - Cal recycle - Yuba county to be submitted on Tuesday, 4/6. On the Radio with police officer, will give an update about Nature Bowl. Will apply and administrate grant for Yuba City Police to hire an officer for illegal dumping. Will capture some funding for admin but not the bulk. Long list of people who want to do cal-recycle, will start doing application reviews in June, then apply in July.

NAQI update: need to submit invoice to NRCS, email from last week says we'll get reimbursed for last invoice (mileage error held it up). Next invoice to be sent soon. Ends at the end of Sept or when funds run out (likely before Sept). Victor will still need to be used for majority of applications due to Kelli's

Mike's grant: parkway: nps conference went good, seemed very positive about the meeting, Dan Flores said County would do whatever needed to complete the

project, should let us know within the next week or so, chances of being accepted looks good, we meet all criteria. Will help us setting up, looking for funding to implement project. If project is accepted, project should be funded with help from nps funding and grants.

Dan Flores has written to stacon(?) about feather river parkway from buttes to sac discovery park.

- 7. Discuss hiring of contractors.

- 9. Review upcoming deadline for Cal Recycle. Next application due in August, in June we will go thru list and will be ranked on the most environmental impacts for priority. In July, we apply for those locations with cal-recycle. One with sherrif dept with sutter co, all admin and administration for grant, funding for officer to enforce illegal dumping laws.

Andre Ingle(?) - only does part, funding is limited, this paves way for full time position for this. In cleaning up river, resources are limited - mike suggested having farmers volunteer equipment twice per month for clean ups - already being done thru samelove(?).
